

It Does This To The Latino Community

- 1. Wipes Out the Office of Civil Rights, rolling back hard-won victories on diversity, equality, and inclusion. (DEI)
- 2. Reduces the budget for Temporary Assistance for Needy Families, disproportionately affecting minority households. (Pg 476, 482)
- 3. Reduces SNAP benefit accounts, additionally dealing a disproportionate blow to minority families. (Pg 300)
- 4. Denies non-citizen and mixed families Federally Assisted Housing. (PG 509)
- 5. Denies student loan access to states that provide in-state tuition to those who lack immigration status.
- 6. Further places legal immigration status out of reach by increasing visa application fees and wait times, while simultaneously limiting the total number of H2-A and H2-B visas issued. (Pg 612)
- 7. Phases out the DACA program for eliminating staff positions that process renewal applications. (Pg 145)
- 8. Repeals the Trafficking Victims Protection Act to allow for mass scale incarceration of migrants at detention facilities. (Pg 150)
- 9. Allows ICE personnel to raid schools, churches, and businesses.
- 10. Deports 15 million people including DACA recipients.

It Does This To The Black Community

- 1. Wipes Out the Office of Civil Rights, rolling back hard-won victories on diversity, equality, and inclusion. (DEI)
- 2. Destroys Medicaid and Medicare, disproportionately eliminating healthcare for minority patients.
- 3. Undoes police reforms, absolving police departments under federal oversight of racial discrimination.
- 4. Encourages draconian sentencing with harsher prison sentences for federal offenders, increasing the over-incarceration of one demographic in particular: Black men.
- 5. Cuts programs related to climate change that disproportionately affect minority communities.
- 6. As it does to other minority communities, Project 2025 negatively impacts the Black community by reducing the budget for Temporary Assistance for Needy Families (Pg 476, 482), reducing SNAP benefits (Pg 300), and eliminating category eligibility. (Pg 296)

It Does This To The Government

- 1. Increase presidential power, bringing the Department of Justice (DOJ) and FBI under direct presidential control, allowing the unmitigated targeting of political opponents
- 2. Replaces 50,000 non-partisan civil servants with presidential "loyalists."
- 3. Fills the courts with far-right "loyalist" judges- this plan has already been underway for many years.
- 4. Creates a "Presidential Administration Academy" that is mandatory attendance for all government employees.
- 5. Allows for the military intervention to break up anti-government protests.
- 6. Promotes isolationist policies.

It Does This To Women

1. Restricts access to reproductive care including abortions, abortive medications such as mifepristone, contraceptives and emergency contraceptives (Pg 458), and the mailing of all such drugs. (Pg 155)
2. Establishes a National Abortion Database that requires states to report all abortions, including personal information about the women receiving them. (Pg 455)
3. Withdraws 10% of Medicaid Funds from states with private insurance policies that cover abortion. (Pg 472)
4. Creates additional avenues to spy on women's private lives under the guise of monitoring and reporting all Abortion-related complications to the CDC, allowing women to be prosecuted while seeking medical care.
5. Reimposes the Comstock Act of 1873 that makes all abortions illegal at the Federal level, which allows Federal prosecution of abortion providers and patients, with penalties up to and including the Death Penalty.
6. Defunds Planned Parenthood, barring millions of women from receiving affordable and life-saving medical care.
7. Ends no-fault divorce.

It Does This To CHILDREN AND EDUCATION

1. Dismantles the US Department of Education
2. Eliminates HEADSTART programs which serve 1 million underprivileged children annually
3. Bars millions of children below the poverty line from receiving free meals at school. (Pg 300-303)
4. Reduces SNAP benefits for families in need (PG 300)
5. Allows children to work in dangerous occupations. (Pg 595)
6. Increases discrimination against 368,000 children in Foster Care.
7. Cuts Title 1 grants by 4.7 Billion dollars, resulting in 72,000 lost teaching jobs in low income areas.
8. Strips funding from public schools to divert money to private, charter, and religious schools.
9. Allows states to create their own school curriculums that eliminate "controversial" parts of US history and social studies, allowing racism and other pressing social issues to remain unaddressed.
10. Reverts all student loans to the private sector and ends Public Service Loan Forgiveness.

It Does This To VETERANS:

1. Removes cost-of-living adjustments for families in urban areas.
2. Halts environmental cleanup on bases, exposing military personnel to hazardous and potentially life-threatening substances,
3. Cuts funding to non-combat related research, including communication, transportation, construction, and forecasting.
4. Increases prices for service members on military bases by combining Military Exchange and Commissaries while reducing Commissary subsidies.
5. Ends retirement payment and disability compensation, and enrollment in VA medical care for Priority Groups 7 and 8 effecting over half a million US veterans.
6. Narrows eligibility for VA disability determinations and puts a 10 year limit on initial disability applications.

It Does This To Seniors

1. Eliminates and privatizes Social Security, Medicare and Medicaid
2. Ends the Affordable Care Act
3. Allows pharmaceutical companies to control the cost of drugs and medicine with no oversight.
4. Limits food and nutrition assistance for more than 4 million people.
5. Forces older women to provide childcare or lose their benefits.

It Does This To CLIMATE EMERGENCY

1. Dismantles the Department of Energy, the EPA, and the National Oceanic and Atmospheric Agency.
2. Cuts/eliminates federal investments to programs related to the environment, including the DOE Loan and DOE's Clean Energy Corps, as well as energy efficiency and renewability programs.
3. Defunds NOAA and eliminates affiliated climate research programs.
4. Ends the EPA's ability to enforce laws related to climate and environment protection.
5. Withdraws from the Paris climate agreement and de-regulates the US oil industry.
6. Moves climate related decisions into the hands of politicians instead of scientists.

It Does This To LABOR LAWS

1. Bans Unions
2. Eliminates protections for laborers who work outdoors and laborers who work for foreign producers. (Pg 296)
3. Attacks OSHA (Occupational Safety and Health Administration) standards, increasing the risk of workplace fatalities and injuries.
4. Decreases protection and safety measures for construction workers. (Pg 604)
5. Ends Project Labor Agreement, decreasing diversity and support for equitable workforce development. (Pg 604)
6. Attacks fair wages by repealing the Davis Bacon Act.
7. Cuts American Rescue Plan (APP) programs that created or saved 220,000 jobs.
8. Cuts overtime pay protections for 4.3 million workers, applies overtime hours for remote after a 10 hour workday instead of an 8 hour workday, and allows employers to calculate overtime over 4 weeks instead of one week. (Pg 587, 589, and 592)

It Does This To The LGBTQ+ COMMUNITY

1. Declares all "Transgender ideology" to be "pornographic." Furthermore, all pornography will be criminalized and it's producers subject to prosecution. Public school and library employees that allow LGBTQ+ media on their shelves will face criminal prosecution, including being forced to register as sex offenders.
2. Eliminates all DEI programs and does away with all LGBTQ+ rights in healthcare, education, and the workplace.
3. Bans same sex marriage.
4. Bans transgender individuals from military service.
